Now in its fifth year, the Public Service Charity 5K Run/Walk celebrates and supports federal public servants across the country, giving public employees a visible reminder they are valued, and offering friends, family, and the broader community the opportunity to come together to thank them.

Hundreds of runners and walkers in the D.C. Metropolitan area participate in the flagship event and hundreds more join in across the country by forming local teams and running and walking in their local communities.

All proceeds from the race support civilian federal and postal workers through FEEA: The Federal Employee Education & Assistance Fund, the event's official charity. Participants are invited to further assist the official charity by soliciting pledges and sponsorship from friends and family supporting their walk/run participation.

VOLUNTEER

Outside the Washington, D.C. metro area we are recruiting "City Captains" to help raise awareness about virtual participation in the 5K.

City Captains:

- Advertise via their personal network and local community by posting flyers and promoting participation via email and social media;
- Suggest local parks or other locations where runners and walkers can meet on race day to sprint, jog, or stroll a roughly
 5 kilometer distance; and
- Help connect registered participants who would like to walk or run as a group on race day.

OUR D.C. LOCATION

The D.C. Run/Walk will be hosted at beautiful Anacostia Park. The park offers a level run/walk waterfront venue and vast park lands for picnicking and recreational sports before and after the race. A pirate ship playground is also available for small children.

Anacostia Park is operated by the United States National Park Service. The park protects the wetlands and woodlands alongside the Anacostia River, providing a habitat for diverse species of animals and plants. The natural areas of Anacostia Park are home to osprey, bald eagles, songbirds, and waterfowl. An abundance of plant life thrives alongside the Anacostia River. Cherry trees, northern wild rice, cattail, Nuphar, milkweed, Joe Pye, and button bush all add to the area's natural beauty.

How to Get There

The park is metro accessible, just over one mile away from the Potomac Avenue Metro Station.

For your GPS: 1500 Anacostia Drive SE, Washington, D.C. 20020.

For those coming from Virginia we recommend approaching the park via the 14th Street Bridge.

There is plenty of free parking onsite and nearby for those who choose to drive.


