## Instructions for Applying to the 2023 FEEA Scholarship Program

**DEADLINE: Thursday, March 16, 2023 at 3:00pm EDT**

Since 1986, FEEA has offered scholarships to more than 11,000 individuals, including providing nearly 200 scholarships to the children of federal civilian employees who died or were severely injured in the line of duty during the terrorist attacks on the Alfred P. Murrah Federal Building in Oklahoma City, the Pentagon on 9-11, and the US Embassies and Consulates in Kenya, Tanzania, and Libya.

FEEA champions the pursuit of higher education and each year supports hundreds of students with merit-based scholarships.

**Scholarship Awards:** Scholarships range between \$1,000 and \$7,500 for one year of academic study at an accredited college or university. The scholarship is not renewable, however, applicants may apply every year they are eligible, whether or not they have received an award in the past. The majority of scholarships are awarded for undergraduate study, with occasional awards for graduate study. Scholarship winners should refer to IRS publication 970 for more information on any potential tax implications of scholarships: <https://www.irs.gov/forms-pubs/about-publication-970>. Scholarship funds may be used for tuition and fees only.

### **Individuals Eligible for Scholarships:**

- a. Full- or part-time permanent civilian federal or postal employees.
- b. Children or legal dependents of full- or part-time permanent federal civilian or postal employees. Dependents must be under the age of 25 and a current dependent of their sponsor.
- c. Spouses of full- or part-time permanent civilian federal or postal employees.
- d. Grandchildren of Blacks in Government (BIG) federal employee members, American Federation of Government Employees (AFGE) members, or Professional Managers Association (PMA) members.
- e. Children, grandchildren, and great-grandchildren of current members of the National Active and Retired Federal Employees Association (NARFE). **NARFE applicants must be high school seniors only.**

The FEEA Scholarship competition is for those attending or planning to attend an accredited institution of higher learning for an undergraduate or graduate degree.

Federal employees, either applying directly or serving as a sponsor, must be employed with the federal government for more than three years as of the scholarship application deadline.

FEEA does not discriminate on the basis of race, color, national origin, age, gender, religion, disability, sexual orientation, or gender identity.

Applicants must have a 3.0 or higher cumulative, unweighted grade point average.

Children, grandchildren, dependents, or spouses applying for support must be enrolled or planning to enroll full-time in their academic program. Federal employee applicants may study part-time.

**Scholarship Funding:** FEEA supports its scholarship program through donations from individuals and a number of partners, including unions, associations, and corporations. For last year's scholarship competition, FEEA partnered with the following groups:

All scholarships are subject to the availability of funding.

**Selection Criteria:** Scholarship selection committee members consider the following factors in ranking and recommending applicants to FEEA:

- Your record of academic and personal achievement;
- Your record of community service and engagement; and
- The substance and quality of your writing throughout the application.

**Award Notifications:** You will be notified of your final application status in August 2023, via the email you use in your application. Scholarship checks are made out to the winner’s college or university and mailed to the home address.

### Application Instructions

- The deadline for the 2023 scholarship application is Thursday, March 16, 2023, at 3:00pm EDT. Applications will not be accepted beyond the deadline. There are no extensions due to weather, computer failure, power outage, or any other reason.

All applications must be completed online via the link at [feea.org/scholarships](http://feea.org/scholarships). Faxed, emailed, or mailed applications will not be accepted. Applications must be started and completed by the student (**parents or grandparents, please do not set up the WizeHive profile or initiate the application for your child**).

- You can begin an application and return to continue working on it at a later date by hitting “Save Draft” at the very top or very bottom of the application, before logging out.

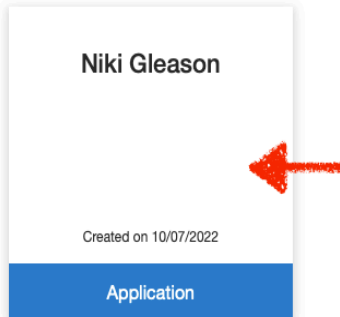


The application is not fully submitted until you click the green “Submit” button. Once you click “Submit”, you will no longer be able to edit your application.

- The Close button will exit the application and prompt you to save any unsaved changes before closing.
- To return to the application, visit the WizeHive site at <https://webportalapp.com/sp/feea> and click “Sign In”. Use the email you registered with and password you selected to complete your login. If you forget your password, you can reset it with the “forgot password” link. After logging in, click the application showing your name to make any changes.

To begin, click "+Get Started" below. Once you have started your application, your name will show on the submission card and when you return to this Homepage, you can see the status of your submission by the colored status bar below the submission card.

- If the status bar is **gray**, your submission is under review, and no action needs to be taken.
- If the status bar is **blue**, there is an action required. Click on the Submission Card to complete.
- If the status bar is **red**, there is an error. Please reach out to the Administrator of this program.



- FEEA reserves the right to verify all information submitted and may disqualify applicants if discrepancies are identified. FEEA will also disqualify applicants for plagiarism.
- Please note, as you fill out the application, some questions will only appear for certain applicants based on your sponsor status.
- Only one application may be submitted per applicant. If you submit more than one application, you may be disqualified. **Please do not use a second email address to try to submit an additional application.**

Below are a few points to keep in mind when filling out the application:

- Everything with an asterisk (\*) is required and must be completed in order to submit the application. Any items not completed will show in red if you attempt to submit the application.
- You must have a current federal employee or retired NARFE or AFGE sponsor. Current federal employees can also sponsor themselves.

## SPONSOR INFORMATION

- If you or your sponsor are a member of one of the membership associations or unions listed in the application, please check that group on the application and provide the local number, chapter number, region number, and/or membership number, if requested, on the form, in order to be considered for support from these organizations. Please note: FEEA will verify all memberships to ensure they

are in good standing and you should only complete this section if you or your sponsor are a current member in good standing of one or more of the listed organizations.

- Sponsor's Agency: This is a lookup menu. Start typing the sponsor's agency in the box to find the correct agency or use "other" if the agency is not listed. See attachment A of these instructions for a complete list of agencies in the drop-down menu. If you do not see the sponsor's specific sub-agency on the list, please use the parent agency. Agencies in Attachment A are listed by parent agency: sub-agency. For example, if the sponsoring federal employee works for the Internal Revenue Service, it is listed as Treasury: Internal Revenue Service (IRS).
- If you are a federal employee applying for a scholarship for yourself, you must upload a PDF copy of your own most recent SF-50 (Notice of Personnel Action) or PSF-50 for postal employees; all other applicants must upload a copy of their federal employee sponsor's SF-50 or PSF-50. The SF-50/PSF-50 must be dated January 2022 or later. If an SF-50/PSF-50 is not available, you must submit the sponsor's most recent pay stub AND a letter from the sponsor's current federal agency supervisor, stating the employee's position title, duty station, GS level (if applicable), and service computation date. The letter must be on agency letterhead and must be physically signed. If using the letter, you must scan together both the letter and paystub into a single PDF file for upload to the application. Please redact sensitive information, such as the Social Security Number and birth date of the sponsor, from the SF-50/PSF-50 or pay stub before uploading. If you are sponsored by a retired NARFE or AFGE member, you are not required to provide an SF-50/PSF-50 unless the NARFE or AFGE member is still an active federal employee.

## TRANSCRIPT REQUIREMENTS

- You must upload a PDF copy of your most recent academic transcript **with fall 2022 grades included.** Unofficial copies are acceptable.
  - Applicants currently in high school: Please upload both a copy of your fall 2022 report card as well as your complete transcript – you will be uploading two documents in two separate places.

- Current college students, please submit your transcript showing your fall 2022 grades in addition to previous transcripts from any other schools attended.
- First-year college students, please submit your college transcript showing your fall 2022 grades and a copy of your high school transcript – you will be uploading two documents in two separate places.
- If you are not currently enrolled, you should submit a transcript from the last school you attended.
- All students, please make sure your uploaded document is not password-protected or locked. If the document cannot be opened by the reviewing committee, your application will be disqualified.
- All students, please redact sensitive information, such as birth date, Social Security Number, or address, from your transcript before uploading.

## **ESSAY, EXPERIENCES, PLANS**

- You must include a 500-word maximum essay answering the following question: *Describe a situation in your school, work, social, or family life, when you demonstrated leadership and overcame obstacles. Explain the situation, what obstacles you faced, and which leadership qualities you used to overcome those obstacles.* The WiseHive platform does not provide formatting options within the text boxes. If you prepare your essay outside of the application and copy and paste into the application form, any formatting will be lost, so please make sure your spacing, punctuation, and grammar are all correct within the text box.
- Provide a numbered list of your most important community service activities that benefit the general community, going back no more than 5 years. Include date(s), length of involvement, hours/month, and a detailed description of your participation, in descending order of significance. Spell out acronyms the first time you use them in a description.
- Provide a numbered list of your most important other (non-community service) extra-curricular activities, including sports, clubs, work, internships, and family responsibilities, going back no more than 5 years. Include date(s), length of involvement, hours/week or month, and a detailed description of your participation, in descending order of significance. Include academic and non-academic activities.

- Include a numbered list describing significant awards received in the last 5 years and what that award recognizes, to include date(s) and description, in descending order of significance.
